DIRECTIONS TO THE SHOW

From the South: US 15 North to Steinwehr Ave Exit. Turn left off ramp onto Business 15 North. Hotel 3 miles on the right.

From the North: US 15 South to Steinwehr Ave Exit. Turn right off ramp onto Business 15 North. Hotel 3 miles on the right

From the East: I-76 PA Turnpike West to Exit 236 (US 15 South). Follow above directions

From the West: I-76 PA Turnpike East to Exit 161 (US301/!70 East) to US 30 East. At Gettysburg traffic circle go around & take Business 15 South. Hotel 5 miles on left.
